# MINUTES FOR THE REGULAR MEETING OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF WANTAGE, HELD AT THE WANTAGE TOWNSHIP MUNICIPAL BUILDING, 888 STATE HIGHWAY ROUTE 23, WANTAGE, N.J., ON APRIL 24, 2014

<u>Mayor DeBoer</u> called the regular meeting to order, and requested the Clerk to call the roll. # Administrator's Report

Mr. Doherty reported on the outcome of the Bid opening for the 2014 Bulky Waste collection program, stating that Blue Diamond Disposal of Succasunna, NJ was once again the lowest bidder.

## **Township Committee Member Reports**

Mr. Bassani reported that he and the Administrator had met recently with the company SDL, to review proposed upgrades to the Township's computer software capabilities for inspections and sharing of date among departments; as a part of that discussion, Mr. Bassani requested SDL to submit a price quote on what they would charge to digitize the Township's tax maps, as a matter of due diligences for price comparison with the amount of money being charged by the Township Engineer.

## **Committee Reports, Continued**

Mr. Bassani also expressed his opinion on an article published in the April 24, 2014, stating that the article, while mostly accurate, incorrectly reported that the actions taken to revise the Assessor's Plan for the Special Assessment on the Lake Neepaulin Dam were the result of legal advice given by Township Attorney Michael Garofalo. Mr. Bassani clarified that the decision to take this action was generated directly from discussion and then decision of the governing body, not as a result of Mr. Garofalo's legal advice.

Mayor DeBoer reported that he, the Administrator, Mr. Garofalo, Township Engineer Harold Pellow, and Land Use Chairman Mike Cecchini met earlier this week with representatives from Sussex Borough to review requests from the Sussex County 208 Water PAC for revisions and amendments to the Wantage and Sussex Sewer Service Areas, and the shared service agreement between Wantage and Sussex for Sewer service billing. Mayor DeBoer stated that Wantage made it clear all utilities, billing and infrastructure would belong to Sussex Borough, as Wantage has no desire to enter the Sewer Utility business. Several properties located on Route 23 were discussed in relation to this topic. The individuals present also reviewed possible details involving tax ratables of a proposed Shop Rite which could be developed along the border of Sussex and Wantage.

# Tax Assessor Report: Special Assessment for Lake Neepaulin Dam Project

The governing body reviewed the Revised Report of Tax Assessor Kristy Lockburner Regarding the Special Assessment for Repayment of the Lake Neepaulin Dam Rehabilitation Project" dated March 21, 2014.

Mayor DeBoer opened the Meeting to the Public for any comments regarding this Report.

Karen Merritt, Alpine Road, thanked the governing body for adjusting the payment obligations but expressed the opinion that the Lake should belong to the Township.

Darren Marquart, 30 South Shore Drive, expressed disagreement with the name "Lake View" property as it relates to his property.

Richard Aaaron, 80 South Shore Drive, expressed the opinion that more than 3 tiers should have been used in the payment plan, expressing concern about the impact on his property.

Bob Heiden, Old Clove Road, agreed with Ms. Merritt's comment regarding ownership of the Lake, and expressed appreciation for the efforts of FOLN.

Ann Smulewicz, Route 23, expressed disagreement with the concept of the Township owning the Lake.

William Gettler, Gemmer Road, offered comments on the history of the Lake Neepaulin Dam issue; expressed reservations regarding whether the beach area would qualify as a public beach; requested the governing body put a question on the November ballot; offered comments regarding the proposed Tier system; expressed the belief the Lake has a negative benefit impact on property values; and expressed the belief that Township was in non-compliance with the Safe Dam Act.

Frank Galligan, New York Avenue, expressed the belief that the lake serves a vital and important role in fire protection for the Lake Neepaulin community, and offered disagreement with Mr. Gettler's positions.

James Sekelsky, Lower Unionville Road, stated he was interested in understanding the implications of the possibility of the Township owning the lake; suggested the matter of legal advice should be balanced with fiscal advice on this topic; observed the need for on-going debt management regardless of future ownership.

<u>Mayor DeBoer</u> stated the Township governing body cannot predict the future; informed that the Township had previously been informed by a representative of NJDEP that the cost to remove the Dam and drain the lake could have cost as much as repairing the Dam.

Mr. Bassani agreed that allowing the Lake to be drained was not a consideration.

Kathy Gorman, Fernwood Road, offered a statement regarding her reasons for wanting to obtain invoices for each line item of the specifications for the Repair of the Lake Neepaulin Dam; spoke regarding her input on upcoming proposed legislation for amending the Safe Dam Act.

William Gettler, Gemmer Road, expressed disagreement with the minutes as approved for the meeting of April 10, stating his belief that he was denied the right to speak so the minutes were incorrect to state that no one else wished to speak when the Mayor closed the meeting to the public. Mayor DeBoer and Mr. Gettler engaged in a brief discussion regarding whether or not he had the right to speak again at that meeting; Mr. Doherty explained that the use of the wording "no one else wishing to address the governing body" was a term of art commonly used by clerks in preparation of minutes, and out of deference to Mr. Gettler, Mr. Doherty would endeavor to avoid using those words in future minutes. Mr. Gettler expressed his views on why he believes the request for copies of invoices on the Dam Rehabilitation project represents a valid request.

Thomas Jable, South Shore Drive, stated that all invoices in the possession of FOLN have already been provided to Mrs. Gorman, and the additional file material requested at the last meeting has been presented to Mr. Doherty for the review of Mrs. Gorman. Mr. Jable expressed the position that there were no other files in the possession of FOLN responsive to Mrs. Gorman's request.

Mr. Bassani thanked Mr. Jable for providing the additional file material as he had promised to do at the last meeting.
