**REPORTS** 

Clerk/Administrator – Mrs. Millikin advised she has been working with Nancy VanHorn on a new electronic sign for the front of the building. The money to fund this project will be done through Clean Community Money that is in place. The quotes received are Stewart Signs \$17,919.00 with the Township installing and removing the sign. E&M Signs is \$23,344.17 + \$1,000 with cellar requirement on a yearly basis. Stewart sign actually did the Sussex Borough Sign, Sussex Wantage Middle School, Ogdensburg, SCARC, Karen Ann Quinlin signs. Mayor Bassani questioned how is the sign changed. It is done through

the computer with WIFI through an antenna on the building to the sign. There will be a need to have the Clean Community Logo along with the Township Seal. Mr. Gaechter questioned if this is a color sign. Mrs. Millikin indicated that it is a color sign. Mayor Bassani questioned some details on the communication. Mr. Gaechter wants to confirm that this is a color sign. Mayor Bassani also questioned how the pixels are handled when they are no longer working. He also questioned the lumens for evening hours. Mr. Gaechter questioned if this is double sided. Mrs. Millikin stated yes. Mr. Gaechter questioned where the money comes from for the sign. Mrs. Millikin explained this is through clean community money for road clean ups, tire turn in day, shred day and he purchases supplies for Wantage Day. Mrs. Millikin stated Mr. Kearins is the one who recommended this project.

Mrs. Millikin stated 173 Clove Road has been demolition. Looks great.

Mrs. Millikin stated Berry Road parcel is scheduled to close on March 21st.

Mrs. Millikin stated that her and Mayor Bassani met with NJDEP regarding RER matter and believes Mayor Bassani will be updating the Committee on this.

Attorney – Mr. Karp advised that the closing is scheduled for Berry Road. Received a letter from the attorney for Clove Hill Manor Association and looking for the Township to take over the roadways. This has been forwarded to Harold Pellow for his review.

Mayor Bassani stated the Open Space Committee is moving forward to finalizing the Open Space and Recreation Master Plan. On March 19<sup>th</sup> is the presentation to the Land Use Board. The Land Conversancy has done a great job with this project. The Open Space Committee will be submitting a grant application at the end of March. Still on hold on the Blue Acres money for Lake Neepaulin boat ramp.

Mayor Bassani stated there was a meeting with NJDEP, Senator Oroho, Assemblyman Wirths, Assemblyman Space were present on the RER matter. The major concern was the odor issue. The one representative regarding odor was brought to the meeting by phone. There will be some homework related to RER and they had information to provide operating within their permit. Mayor Bassani stated that NJDEP is looking at regulation changes. One item specific is a modification would require Township approval. Mrs. Millikin advised that it was also recommended that this go back to the Land Use Board on an informal basis. The current regulation is local complaints. There is the need that a business or person who lives within this area to make a complaint. The person has to remain on site to meet with the inspector when they come out to do the inspection. Mayor Bassani is going to make an effort to speak with the business owners in this area to make a complaint. Mrs. Millikin indicated one of the biggest issues is the fact that this seems to happen on the weekends. Mayor Bassani stated it was great to have Senator Oroho, Assemblyman Wirths, and Assemblyman Space at the meeting. Mrs. Millikin advised that the Township and NJDEP will most likely have a meeting with RER at some point on this matter. Another issue brought up was if the RER business were to leave the

site a bond should be posted to clean up the site. Recycling rules will be changing in 2022.
