Administrator's Report

Mr. Doherty reviewed several issues which had been placed in the "Pending Status" folder with the governing body, asking if any action was desired at this time.

Regarding the issue of Encroachment upon municipally owned property along Lake Neepaulin on South Shore Drive, the members of the governing body agreed to review their file material and make a site inspection for further consideration to take place at the next meeting.

Regarding the request for consideration of <u>Vacating a portion of unimproved road between Route</u> 23 and <u>Mudtown Road</u>, the members of the governing body reached consensus to agree with the positions of the 2004 and 2009 governing bodies, and retain this parcel as an abandoned but not vacated street.

Regarding the <u>Suggestion for renovating and Deed-restricting Block 117 Lot 17</u> as a COAH-eligible affordable housing unit, the governing body chose to retire this concept with no action at this time, reserving the right to revisit the concept in the future if deemed to be appropriate.

Regarding the proposed <u>Tree Removal Policy</u> for felled trees on municipally owned lots resulting from storm activity, the governing body retired this concept with no action.

Regarding the suggestion of <u>Limiting the Number of Peddler Permits allowed in the Township</u> at any given time, the members of the governing body requested Mr. Garofalo present some suggestions and examples of such legislation from other communities, at the next meeting.

Attorney's Report

Mr. Garofalo reported on the status of the State's efforts to claim unused local COAH developer fees from municipalities.

Township Committee Member Reports

Mr. Gaechter and Mr. DeBoer offered congratulations to Mayor Bassani on his Primary Election victory. Mayor Bassani thanked Mr. Gaechter and Mr. DeBoer for their kind words.

Mayor Bassani reported that the Reassessment Newsletter has been mailed, and commented that it was apparent to him from recent interactions with members of the public that there is some significant level of misunderstanding and misrepresentation going on around town regarding the details of the special assessment issue in Lake Neepaulin. Mayor Bassani indicated a desire to utilize the Township website more effectively and to a greater degree in the future as a tool for educating and communicating with the public. Mayor Bassani also mentioned that the County would be holding a Complete Streets Study meeting next week. Mr. Doherty indicated he would be attending this meeting.

OLD BUSINESS

Soil Removal Permit Renewals

General review on the status of the 284 Aggregates site and the Bicsak site took place. Mr. Doherty detailed items the applicants needed to address in order for their applications for license renewal to be given consideration by the governing body. No action took place at this time.

Volcanic Hill Road Petition

General review and discussion took place regarding a Petition submitted from various property owners of Volcanic Hill Road, requesting the Township commence the process of accepting Volcanic Hill Road as a public street. Mr. Doherty and Mr. Garofalo explained various procedural steps involved in this process, the first being for the governing body to determine if indeed they wish to accept the road as a public street. After general discussion, no action was taken at this time.
