Mr. Garofalo reported that all successful bidders on the sale of municipal property have been contacted and deed transfer paperwork is ongoing.

The governing body reviewed a request from a resident on Newman Road for a Bus Stop to be located. General consensus was to forward this request to the Sussex Wantage School district for their consideration.

Township Committee Member Reports

Mr. DeBoer requested that pavement be put down in front of the First Aid Storage Shed on the side of the First Aid Squad building,

<u>Mayor Bassani</u> announced that the Chinkchewunska Chapter of the Daughters of the American Revolution are celebrating the 226th Anniversary of the United States Constitution during America's Constitution Week, September 17-23, 2013. Mayor Bassani offered the following Proclamation:

PROCLAMATION: CONSTITUTION WEEK

Whereas, September 17, 2013 marks the two hundred and twenty-sixth anniversary of the drafting of the Constitution of the United States of America by the Constitutional Convention; and

Whereas, it is fitting and proper to officially recognize this magnificent document and the anniversary of its creation; and

Whereas, it is fitting and proper to officially recognize the patriotic celebrations which will commemorate the occasion; and

Whereas, public law 915 guarantees the issuing of a proclamation each year by the President of the United States of America designating September 17 through 23 as constitution week;

NOW, THEREFORE, I, RONALD BASSANI, Mayor of the Township of Wantage, do hereby proclaim September 17 through 23, 2013 to be CONSTITUTION WEEK In the Township of Wantage, and ask our citizens to reaffirm the ideals the Framers of the Constitution had in 1787.

Third Party Energy Options

<u>Mayor Bassani</u> offered an update report on a meeting that he and the Chief Finance Officer had with representatives of Concord Energy, a coordinator of Government Energy Aggregation Programs which could provide savings to residential and commercial customers within the Township. General review and discussion of this possibility took place. No action was taken as none was called for at this time.

<u>Mayor Bassani</u> reported on a meeting he attended with representatives of JCP&L, in which reports and details were offered regarding JCP&L's ongoing efforts to improve their service and response efforts in times of emergency.

Mayor Bassani offered an update report on meetings with Verizon, concerning the possible placement of a cell tower on the municipal building property location. This would generate approximately \$2,000 a month in revenue for the Township. Verizon will place a crane alongside the municipal building raised to a height that would simulate the height of the cell tower, as a visual aid in understanding the proposed height of the structure. No action was taken on this matter.

<u>Mayor Bassani</u> reported that efforts to proceed with a natural gas service line being extended to the municipal building property have been successful and this project will be proceeding.

<u>Mayor Bassani</u> reported that the Sussex County League of Municipalities has requested municipalities support two issues, the first supporting that public work projects under \$100,000 not be subject to prevailing wage requirements, and the second involving distribution of cost burden for tax appeal refunds to be shared equitably with boards of education and county budgets, rather than the cost burden falling completely on a municipal budget. All members of the governing body agreed with these measures by consensus.

Mayor Bassani stated the Township would follow up with formal steps for calling the bond if satisfactory progress is not accomplished by the next meeting.
