Mr. Eric Schlueter of Bridle Way was invited to attend tonight's meeting regarding concerns with the condition of Bridle Way and Martingale Drive for discussion with the Committee and Harold Pellow. Mr. Schlueter was not present. Mr. Pellow addressed the issue.

Vernon Township has made an offer for the renewal of the 911 Dispatch Contract. The Committee decided to discuss this issue during Executive Session.

Upon discussion, the Committee decided that no action will be taken on a drainage ditch issue as it is a neighbor to neighbor dispute.

Regarding a Professional Services Contract: As of the deadline of this report, a final copy of a proposed contract with Ken Nelson for Planning Services associated with designation of properties in need of redevelopment was not been received. It is anticipated that action shall take place at the January 8, 2015 Committee meeting.

Committee Member Report - Committeeman Bill Gaechter offers that Wantage Residents can save 50% at Mountain Creek.

Engineer's Report

- 1. Harold Pellow offers that numerous roads have been repaved this year, including Kearny Drive, Maida Drive, Old Clove Road, Rutgers Road, Bergen Avenue. Passaic Avenue, and Volcanic Hill Road. Mr. Bassani feels that Volcanic Hill Road is too narrow, but all agreed that the completed project looks good, as does the project completed at Colesville Fire Department.
- 2. Mr. Pellow elaborated on the updated 5 year plan, incorporating Lake Neepaulin, Sections 2 and 3 of Pidgeon Hill Road, the reclamation of Lower Unionville Road. He added that asphalt prices have increased from \$23 to \$80 per ton. Mr. Pellow is seeking to increase the time frame between road repairs. All roads cannot be done, if is cost prohibitive.
- 3. Rolling Hills Estates will be done by June 1. Upkeep of detention areas and basins needs greater attention. Mr. Pellow states that Rolling Hills has been very cooperative.
- 4. Mr. Pellow offers that a Digital Tax Map will probably be completed in late spring and submitted for State approval. Attorney Glen Kienz questioned if Mr. Pellow is an "Official Township Surveyor," and OTS eligible.

- 5. Regarding Soil Removal specific to properties associated with Mr. Bicsak, Mr. O'Krepky, and Mr. Zummo, Mr. Pellow indicates that he will be able to supply that information by next week. He suggests that temporary approval may be needed.
- 6. Mr. Gaechter asked Mr. Pellow about the Roy Road project. Mr. Pellow replied that nothing has happened, and that the project has died.

Warren Wisse reminds all that the Christmas Tree Lighting is scheduled for December 5, 2014, at 7 PM.

Karen Merritt adds that the event is the 25th Anniversary of the Wantage Christmas Tree Lighting.

Jackie Espanoza, of Jersey Central Power & Light, indicates that there was one issue during the storm, and that it was resolved. She thanks the people for their patience. She states that there were 750 outages the day before Thanksgiving, and 19 outages on Thanksgiving day.

Kathy Gorman offered a packet of information to Attorney Glenn Keinz regarding the use of Lake Neepaulin. She stated that her investigations reveal that "swim at your risk" is not a good idea and referenced the "Land Owners Liability Act. "Furthermore, the act of charging a fee makes the Township liable. No fee equals no damages, per Case Law. Ms. Gorman adds that even a nominal fee, \$1.00, makes the owner liable. There is a duty to children, as a child cannot understand the concepts of "swim at your own risk." Additionally, the words "swim at your own risk" do not cover all possible accident scenarios – for example, someone might be injured by diving. She states that all bases cannot be covered and adds that depths must be shown.

Ann Smulewicz agrees that swimming in Lake Neepaulin is not a good idea. She commended Judge Dana for his stellar career.
