# MINUTES OF THE REGULAR MEETING OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF WANTAGE, HELD AT THE WANTAGE TOWNSHIP BUILDING, 888 STATE ROUTE 23, WANTAGE, NJ, HELD AT 7:00 P.M. ON <u>April 12, 2018</u>

Mayor Gaechter called the meeting to order and requested that the Clerk call the roll. Upon roll call, the following members of the governing body were present: Mayor William Gaechter, Deputy Mayor Ronald Bassani, and Committeeman Jonathan Morris. Also, present: Administrator/Clerk Debra Millikin and Glenn Kienz, Esq.

Mayor Gaechter stated, "This meeting is being held in compliance with the provisions of the Open Public Meeting Act, P.L. 1975, Chapter 231. It has been properly noticed and certified by the Clerk."

# PUBLIC HEARING: 2018 MUNICIPAL BUDGET

Mayor Gaechter stated the meeting will begin with the 2018 Municipal Budget Presentation. Mrs. Millikin stated on behalf of the Township of Wantage I am happy to present the 2018 Municipal Budget. My thanks to Michelle LaStarza for all her assistance as the Chief Financial Officer as well as Thomas Ferry the Township Auditor. This year's total operating budget is an increase of \$1,262,621. The reason for this increase is for the acquisition of property through Green Acres. If the parcels are not purchased then this amount will be less including grant funding. Mayor Gaechter stated that this is being funding by grant funding. Mrs. Millikin stated yes through grant funding and money already raised through Open Space Funding. Mr. Bassani said there is no impact on the taxes.

Mrs. Millikin stated on page 3 is the Debt Service that the Township paid in 2017. One key aspect of this page is Debt Service payment is going down. On page 4 is the proposed capital plan. Mrs. Millikin stated this proposed capital plan provides a five-year estimated plan of capital expenses needed. One of the biggest investments the Township needs to continue is road infrastructure. The Township has over 120 miles of that the Township is responsible to maintain. Local road repair is also utilized on the roadways, which the DPW helps to complete. The proposed road projects for 2018 are: Spreen Road from the end of the paved area to the Lafayette border, Lewisburg Road from Spreen Road to the second top of the hill, Dales Crossing, Mt. View Drive, Liberty Street, North Shore Road, Wantage School Road from Route 23 to Rose Morrow Road, Newman Road DOT grant funding was received and Sherman Ridge Road also DOT grant funding from Brown Road to Libertyville Road. Oil & Stone: approximately 10 miles of roads will be completed with Oil and Stone. 7 items in the 2018 proposed capital budget will require bonding.

Mrs. Millikin stated the proposed 2018 Municipal Budget is a flat tax rate of \$0.294. Total budget for 2018 is \$7,319,458. The main reason for this increase is due to the acquisition of property through the Open Space Trust Fund and the grant funding associated with these purchases. Mrs. Millikin stated the top five expenses for the 2018 budget are Road Repair & Maintenance \$1,359,051, Debt Service \$974,680, Employee Health, Pension, Etc. \$671,263, Reserve for Uncollected Taxes (RUT) \$652,033, and Public Safety \$395,822. Mrs. Millikin stated the Reserve for Uncollected Taxes or RUT is a mandatory appropriation that has to be placed in he budget. The payments to be made to the Schools and County are the reason for this appropriation. As you can see over the past 5 years the RUT

fluctuated. The RUT for 2018 decreased by \$174,960 due to a large jump in our tax collection rate. Mr. Bassani questioned if there has ever been a time the RUT was lower than the numbers show over the past 5 years. Mrs. LaStarza stated no it always been a pretty high number.

Mrs. Millikin next moved to the Fund Balance. The Fund Balance or Surplus is a comparison over the past 5 years of the money utilized to help balance the budget. The Township does have a fund balance policy and it is important to try to build on fund balance each year. Mrs. Millikin stated the balance at the end of 2017 was \$1,202,874. Of this amount the Township is utilizing \$686,900 of this balance. On page 9 this page provides a breakdown paid for Wantage Residents. Mrs. Millikin stated this proposed breakdown is estimated tax rate for the public to see how much of the taxes paid actually goes to Wantage Township. Again this is estimated because the County nor the School have their tax rates established. The County of Sussex received 20.01%, Library Tax 1.25%, County Open Space .08%, Sussex/Wantage School District 41.80%, High Point Regional School District 25.73% and then Wantage Township 11.13%. In closing my thanks to the Township Committee, all the Departments, Township Engineer, Auditor and staff for their efforts in putting together a budget. Mayor Gaechter stated his goals in January each year is the budget. The budget is a very important task and take this job very seriously. It is always a happy day to have a 0% increase. Thank you to all involved.

Mayor Gaechter stated a motion is in order to adopt Resolution #46-2018 the adoption of the 2018 Township of Wantage Municipal Budget.

A motion was made by Mr. Bassani and seconded by Mr. Morris.

Mayor Gaechter opened the hearing to the public.

Mr. Daniel Veit questioned on the last page the Health Service percentage. Mrs. Millikin stated the Health Service tax use to be a separate tax but has been incorporated into the County tax. There being no other public comment the public hearing of the 2018 Municipal Budget was closed.

# ORDINANCE # 2018-06

#### AN ORDINANCE AMENDING SECTION 11-3 ENTITLED "ALLOCATION OF THE DISPOSAL OF SEWAGE" OF CHAPTER XII ENTITLED "SEWER AND WATER" OF THE "REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WANTAGE, NEW JERSEY

WHEREAS, the Sussex County Municipal Utilities Authority ("SCMUA") has provided the Township of Wantage with an allocation and apportionment of the volume of sewage disposal capacity that it has at its wastewater treatment facility located in Hardyston Township on a proportionate basis with other municipalities within the area of the Wallkill Basin; and

WHEREAS, in order to ensure that the Township's sewer allocation is fully utilized, it is the intent of this Ordinance to require owners of real property located in the Township to first reserve and utilize any unused sewer allocation that is needed for the development of their property from the Township before such property owner may seek to obtain a sewer allocation from another municipality or any other source.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Committee of the Township of Wantage, County of Sussex, State of New Jersey as follows:

Section 1.

Section 11-3 of Chapter XII of the Revised General Ordinances of the Township of Wantage is hereby amended and supplemented to add the following new subparagraph 11-3.4:

## 11-3.4 <u>Reservation of Sewer Allocation For Development</u>.

Every owner of real property located in the Township of Wantage that requires reserve capacity for wastewater treatment at the Sussex County Municipal Utilities Authority's ("SCMUA") wastewater treatment facility for the development of the property, must first utilize any unused sewer allocation that has been allotted to the Township of Wantage by SCMUA or obtained by or for the property prior to the effective date of this Ordinance, before such property owner may seek to obtain a sewer allocation from another municipality within the service area or any other source. If an allocation is available, the property owner must enter into a sewer allocation agreement with the Township as a precondition to applying for any and all land use approvals necessary for the development of the property.

## Section 2.

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

Section 3. Effective Date. This Ordinance shall take effect immediately upon final passage and publication according to law.

## AUTHORIZING THE TOWNSHIP OF WANTAGE TO ENTER INTO AN AGREEMENT WITH MAXIM & ANN SMULEWICZ FOR PAYMENT OF PROPERTY TAXES BLOCK 11, LOT 6.01

WHEREAS, Maxim Smulewicz and Ann H. Smulewicz (the "Smulewiczs") own premises located at 108 Route 23 in the Township of Wantage, County of Sussex and State of New Jersey, known and designated as Block 11, Lot 6.01 on the Official Tax Map of the Township; and

WHEREAS, the Smulewiczs are in arrears in the payment of real estate taxes for the property; and

WHEREAS, the Smulewiczs are desirous of obtaining a zoning permit and other approvals necessary to occupy the property by a tenant; and

WHEREAS, the Ordinances of the Township require all taxes and other charges to be current prior to the issuance of a zoning approval and/or other approvals; and

WHEREAS, the Smulewiczs have requested that the Township agree to a tax installment payment plan to allow the issuance of the zoning permit and other approvals; and

WHEREAS, the Township is permitted to enter into an installment payment agreement pursuant to N.J.S.A. 54:5-19 et seq.; and

WHEREAS, the Township has agreed to enter into a tax installment plan pursuant to the statutes; and

WHEREAS, the size, nature and location of the property, including conditions on adjoining property are such that a payment plan is desirous to promote the economic viability of the Township and necessitates the need for this specific parcel to remain viable, through an installment payment plan; and

WHEREAS, the proposed payment plan is short-term; and

NOW THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Wantage, in the County of Sussex and State of New Jersey, as follows:

The Mayor is authorized to execute such documents as shall be approved by the 1. Mayor and Township Attorney to confirm the Township's agreement to the terms set forth in this Resolution.

This Resolution shall take effect immediately.

Mr. Kienz stated that also in discussion regarding the vacant property registration that was taken over by Veteran's Affairs. Due to the fact this is the Federal Government is not being required to be paid because it is a tax. The Committee was in agreement to waive Vacant Property Fee.
