Mrs. Millikin advised interviews were conducted last week with the candidates for the Court Attendant Position. Based on the interview process Frank Philhower a retried policeman who is currently working at the Sherrif's Department and the Newton Court is being recommended for the position. The Judge, Court Administrator and myself were involved with the interviews.

Mrs. Millikin advised that she will be on vacation from July 14th through July 21st on vacation at Lake Cayuga.

Mr. Bassani stated he had an opportunity to attend the church ground breaking ceremony. This is the culmination of two churches both Colesville and Libertyville. The

true ground breaking will be in 2019. This is the first church to be opened in the County in a decade. Wish them all the best with this project.

Mr. Morris stated the SWAC meeting was postponed till September. A resident called about the Clove Road Property. Mrs. Millikin stated that the fence was placed up due to the judgement for securing the site. She advised she has put the specifications together to obtain quotes for the demolition and she has provided to Joe Butto for comment. She has to make some changes and wants this to get out for quotes in the next couple weeks and hopefully demo for September.

Presentation of 2017 Audit

Mayor Gaechter introduced Thomas Ferry, Township Auditor, for the presentation of the 2017 Audit.

Mr. Ferry thanked the Mayor and Committee. He questioned if the Committee had a copy of the Audit which they indicated yes. Mr. Ferry went over the requirements for the audit and the General Audit Standards and Government Standards and Compliance. Mr. Ferry discussed the audit process with the Committee. He advised there were no comments or recommendations and this is a very good thing. There are minor items we provide to Ms. LaStarza and Mrs. Millikin. He directed them to page 59 and 60. Took in \$34,000,000 in revenue which includes the County and Board of Education. Only \$.16 a dollar stays in the Township of Wantage. He discussed the use of some fund balance to balance the budget. The Township had more money placed in the fund balance for 2018. Mr. Ferry stated that most fund balances should be 10% of your tax Levy. You should have about 3.4 million. The Township of Wantage is right in the middle. This is mainly due to this time of the year when the tax rate has not been struck. He also talked about tax title liens which if this is done this brings properties back on the tax roles. Mr. Ferry stated this is the basic audit report.

Mr. Ferry said the Township debt is about \$7 million and based on this your annual average is about .64% which is good. He discussed the matter of permanent bonding but based on the interest rate through the current notes there is not a need at this time. The Committee thanked Mr. Ferry.

WHEREAS, <u>R.S.</u> 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

WHEREAS, the Local Finance Board has promulgated <u>N.J.A.C.</u> 5:30-6.5, a regulation requiring that the governing body of each municipality shall, by resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations; and

WHEREAS, the members of the governing body have personally reviewed, as a minimum, the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations, as evidenced by the group affidavit form of the governing body attached hereto; and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of <u>R.S.</u> 52:27BB-52, to wit:

<u>R.S.</u> 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

NOW, THEREFORE BE IT RESOLVED, That the Mayor and Committee of the Township of Wantage, hereby states that it has complied with <u>N.J.A.C.</u> 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.
