Mayor Gaechter questioned how the next motion could occur with the payment for PO #15471 for Bassani Power Equipment, LLC. Since there is not a majority to vote on this payment this will have to be held to the September 13<sup>th</sup> Meeting.

# REPORTS

Clerk/Administrator - Mrs. Millikin advised there were a total of 13 OPRA request for the month of July.

Mrs. Millikin provided an update that the milling and paving has been progressing in the Township. The milling will be completed today. Paving is still being finished on Wantage School Road, North Shore Drive, Lewisburg Road, Spreen Road, and Holland Road. The paving crew should be done by next Wednesday.

Mrs. Millikin advised she has received several e-mails and calls from residents on Dales Crossing regarding the speeding on their road and request for speed bumps. In reviewing the Township Ordinance there is no speed listed in the ordinance for Dales Crossing so she has requested that Mr. Pellow do a traffic/speed study to establish a speed for the road and also advise if speed bumps are warranted. At this time, I have advised the various residents in the Dales Crossing area that speed bumps were not budgeted and base on the traffic survey it will allow the Township to analysis the need.

Mrs. Millikin stated last year regarding COAH the Township agreed to exempt the fee. She indicated a resident who is moving into the Township has constructed a new home and wanted to know if the Committee is interested in waiving the fee. Mayor Gaechter stated that he wishes COAH would not exist and stated that he would refer this to Mr. Kienz. Mr. Kienz stated that at this time the Township should stay the course and not amend this at this point. Mr. Kienz stated that the Township might want to look some one running into the COAH trust and housing.

Mrs. Millikin advised that on the dais is the final draft of the soil ordinance and would like introduce for September 13<sup>th</sup>. She advised that Mr. Pellow has been sent this for his review.

Mrs. Millikin stated a Narcan training is being held here at the Municipal Building on August 15<sup>th</sup>. The event is being sponsored by Center of Prevention and Counseling and Morris County Prevent is Key, Inc. You must pre-register for the event at either (973) 625-1998 or <u>Eshortway@mcpik.org</u>. Mr. Bassani advised that if registering by e-mail identify this as the Wantage training.

Mrs. Millikin stated on August 27<sup>th</sup> at 7:00 p.m. will be a workshop on the 2018 Wantage Township Open Space and Recreation Plan Update. She is encouraging the public to attend.

Mrs. Millikin stated she would like to set up a vehicle meeting. The Committee requested that an e-mail be sent out with dates and meet after 4:00 p.m. Mayor Gaechter stated that with regards to the First Aid Squad that a specific person is responsible for all vehicles is the engineer and to coordinate to have him at these meetings.

Mrs. Millikin brought up the Gemmer Road vacation where it dead ends. The property owner has requested that this be brought up for discussion. There is a need for a turn around on this matter. Mayor Gaechter requested that Mrs. Millikin get them the information including the tax map for the September 13<sup>th</sup> meeting.

Mrs. Millikin advised that she will be off on August 22<sup>nd</sup> through the 24<sup>th</sup>.

# Attorney – none

Mayor/Committee – Mayor Gaechter stated he has been fielding a great deal of phone calls regarding the Route 23 project. Mayor Gaechter questioned if the Township has a direct contact. This is a traffic hazard off Pond School Road, and also when will work happen.

Mayor Gaechter stated the stench at RER has been horrendous and wants this on the record.

Mayor Gaechter stated the paving looks good and would like to talk to Mr. Pellow regarding the speed for Dales Crossing. Mrs. Millikin stated she feels this might be a cut through for Snoover.

Mr. Bassani – none.

# OLD BUSINESS

Mayor Gaechter stated that he wants to bring up the beer tent for Wantage Day. Mayor Gaechter stated he gives his approval and Mr. Bassani also in favor. Mrs. Millikin stated that it is recommended by the Risk Manager that a third-party vendor be responsible for a social affairs permit. Mayor Gaechter stated having Skylands. A questioned was raised regarding the alcohol being prohibited in the park. Mrs. Millikin stated a resolution to authorize this would be required.

# **OPEN PUBLIC SESSION**

Mayor Gaechter opened the meeting to the public.

Kathy Gorman – Fernwood Road, Wantage, stated she had advised the Recreation Committee to attend the Open Space meeting on the 27<sup>th</sup>. Mrs. Gorman stated there was a bit of a dispute at the meeting about the Recreation Committee Meeting with Land Conservancy. She stated that during the meeting Recreation does not want any more fields. Mrs. Gorman stated the question is can the Township utilize the funds for repairs to the fields. Mrs. Gorman feels the Township should purchase more open space. Mayor Gaechter stated that Open Space is unique with purchasing land, but then becomes part of Recreation to look at fields. What fields are the issue? Mrs. Gorman stated Lott Road. Discussion ensued. Mr. Bassani stated Open Space is to acquire properties for both active recreation and passive recreation. Original goal to purchase the perimeter of Wantage. Mr. Bassani stated he does not know if moneys can be used for maintenance of the fields. Mr. Kienz stated he will look into this matter. Mrs. Millikin indicated she did meet the next day with Mrs. Dunn, Ms. Tuper, and Mrs. Davis and it was a great meeting.

Jackie Espinoza from JCP&L she was here to talk about JCP&L Reliability Plus. This is a infrastructure investment by JCP&L. Mrs. Espinoza described some of the upgrades to the

infrastructure. She indicated the cost is about \$.25 for the first six months, and could go up a quarter with a cap of \$1.89. Mrs. Millikin advised this will be discussed at the next Sussex County League of Municipalities Meeting as well. Mayor Gaechter stated that he feels that Wantage is on the back burner when there are outages. Mrs. Espinoza stated it is based on the Newton substation. She is looking for support from the Township on this infrastructure project.

John Gramignano – Coykendall Road, Wantage, stated he has been taking care of the Township fields for the past 8 years. Please ask me what has been done over the past 8 years. He said he has spent over 4,000 hours on fixing and redoing the dugs outs. He stated the baseball field at Woodbourne Park needs work. Mr. Bassani stated he needs to understand what is required to be completed and would like some detail on his knowledge. Mr. Gramignano stated the fields need better maintenance.

There being no other public this portion of the meeting was closed.
