WANTAGE TOWNSHIP RESOLUTION #68-2019 TO SUPPORT THE HUMAN TRAFFICKING AND CHILD PREVENTION EXPLOITATION PREVENTION ACT

WHEREAS, human trafficking is a global phenomenon that traps millions in cycles of exploitation for sex or labor and is often called "Modern slavery"; it is a direct affront to individual human rights and jeopardizes community health; and

WHEREAS, the Hampton Township Committee have a compelling interest in protecting the public health and protecting minors from being exposed to obscenity through products sold by Manufacturers and Wholesalers that distribute on the Internet; and

. WHEREAS, New Jersey Assembly Bill A878 and New Jersey Senate Bill S540 make it an unlawful practice under the consumer fraud act to manufacturer, sell, offer for sale, lease or distribute a product that make content accessible on the Internet unless the product contains digital blocking capability that renders any obscene material inaccessible; and

WHEREAS, it would be an unlawful practice for a minor to receive such a product unless the digital blocking capability is active and properly operating; and

WHEREAS, under these Bills a person who manufactures, sells, offers for sale leases, or distributes a product that makes contact accessible on the Internet is to

1- Make reasonable and ongoing efforts to ensure that the digital content blocking capability

functions properly; Establish a reporting mechanism, such as a website or call center to allow a consumer to

report unblocked obscene material or report block material that is not obscene; 3- Ensure that all child pornography and revenge pornography is inaccessible on the product; 4- prohibit the product from accessing any funds that facilitates prostitution 5- Render websites that are known to facilitate human trafficking inaccessible; 6- Manufacturers and Wholesalers that distribute on the internet or make content on the internet

accessible install filters that will protect consumers from accessing child pornography and

incurring criminal liability; 7- A person who manufacturers, sells, offers for sale or leases or distributes a product that make

content accessible on the Internet may elect to pay a twenty dollar opt-out fee for each product that enters New Jersey's stream of commerce; and

WHEREAS, any digital blocking capability may be deactivated after a consumer

1- Requests in writing that the capability be disabled 2- Present identification to verify that the consumer is 18 years of age or older; 3- Acknowledges receiving a written warning regarding the potential danger of deactivating the digital blocking capability 4- Pay a one-time twenty-dollar digital access fee; and

WHEREAS, the twenty-dollar deactivation tax funds could be used by government and non-government groups working to uphold community standard of decency and to fight sex crimes and provide grants for government and non-government groups that are working against indecency, sexual assault, human trafficking and domestic violence; and

WHEREAS, an unlawful practice is punishable by a monetary penalty of not more than

\$10,000 for the first offense and not more than \$20,000 for any subsequent offense. Additionally, a violation can result in cease and desist orders issued by the Attorney General, the assessment of punitive damages and the awarding of treble damages and costs to the injured.

NOW, THEREFORE BE IT RESOLVED that the Wantage Township Committee hereby supports New Jersey Assembly Bill A878 and New Jersey Senate Bill S540 which Support The Human Trafficking and Child Prevention Exploitation Prevention Act

RESOLUTION PROCLAIMING TO LOCAL RESIDENTS AND BUSINESSES THAT THE MUNICIPALITY WILL NOT COLLECT NEW STORMWATER MANAGEMENT OR RAIN TAXES

WHEREAS, bill S1073/A2694 authorizing municipalities and counties to establish stormwater utilities was signed into law by Governor Phil Murphy; and

WHEREAS, municipalities or counties that choose to establish a stormwater utility will be allowed to apply an undetermined tax on property and business owners based on the amount of impervious surface they have, often referred to as a rain tax; and

WHEREAS, there is no limit to the amount property owners and local businesses can be taxed as long as it can be justified as going towards improving stormwater management, however, 5 percent or \$50,000 of the revenue is required to be paid to the state and another 5 percent can be used for a locality's general fund; and


WHEREAS, sewage authorities must adhere to a two-percent cap on annual increases to property owners and businesses, but stormwater utilities will not have to adhere to the cap; and

WHEREAS, municipalities and counties already have stormwater systems in place that manage stormwater without the need of creating another level of bureaucracy; and

WHEREAS, New Jersey property taxpayers already pay the highest taxes in the nation, and the creation of any new tax is an impossible burden to put on their backs; and

WHEREAS, New Jersey's Business Tax Climate was named last in the nation by the nonpartisan Tax Foundation, and any new taxes to our business owners are not feasible; and

WHEREAS, State Senator Steve Oroho, Assemblyman Parker Space, and Assemblyman Hal Wirths are calling on municipalities and counties to come together and signal to their tax-paying residents and businesses that they're aware that New Jersey's tax burden is already too high by making their intentions known through this resolution; and now be it



and sympathizes with the heavy tax burden already placed on New Jersey residents and businesses and, therefore, will not charge them an extra tax for having driveways, parking lots and other impervious surface
