Finding - Finance

The Analysis of General Capital Fund Cash includes a cash deficit for an Ordinance over 5 years old.

Response

A capital ordinance in 2003 was partially funded by a Grant from the NJ DOT. When permanent financing was undertaken, bonds were not issued. Further investigation showed the final amount expended for the project exceeded the amount of the grant and should have been funded. Since the ordinance is over 10 years old, it can only be funded as a deferred charge to future taxation in future years.

Corrective Action

A deferred charge to future taxation will be raised in all budgets starting in 2020 until the \$140,000 deficit is fully funded.
