

**TOWNSHIP OF WANTAGE
ORDINANCE #04-2021**

**AN ORDINANCE AUTHORIZING AND DIRECTING THAT TITLE AND
POSSESSION OF A PORTION OF CERTAIN REAL PROPERTY LOCATED IN TAX
LOT 11 IN BLOCK 143 AND LOT 3.01 BLOCK 142 AS SET FORTH ON THE
OFFICIAL TAX MAP OF THE TOWNSHIP OF WANTAGE SHALL BE ACQUIRED
BY PURCHASE OR GIFT**

WHEREAS, Gemmer Road, a portion of which is unimproved, is a right-of-way and/or paper street located within the Township of Wantage, County of Sussex which was previously created for public use; and

WHEREAS, the Township Committee of the Township of Wantage has determined that the public interest would be best served by abandoning, vacating, releasing and extinguishing any and all public rights which the Township may have in and to a portion of Gemmer Road; and

WHEREAS, the Township Committee of the Township of Wantage has determined that in order to provide adequate turn around on Gemmer Road to replace the portion of Gemmer Road which is being vacated, it is necessary to create a k-turn adjacent to Gemmer Road, and

WHEREAS, the property owner of the property which adjoins the portion of Gemmer Road which will be vacated has offered to convey a portion of his property to the Township for the creation of the area for the k-turn and has agreed to pay all costs associated therewith; and

WHEREAS, it is in the Township's best interest to accept the aforementioned roadway dedication and any associated dedications, if any.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wantage that:

Section 1. Authorization to acquire a roadway dedication and any other dedications, if any, as contained on a map entitled "Proposed K-Turn at Gemmer Road, Wantage Township, Sussex County, New Jersey, R.O.W. Vacation Plan" prepared by Harold E. Pellow, P.E. & L.S. dated November 21, 2019.

Pursuant to the provisions of the "Local Land and Buildings Law", N.J.S.A. 40A:12-1 et seq., the Township Council of the Township of Wantage hereby accepts the aforementioned roadway dedication for "Proposed K-Turn" as contained on a map entitled "Proposed K-Turn at Gemmer Road, Wantage Township, Sussex County, New Jersey, R.O.W. Vacation Plan" prepared by Harold E. Pellow, P.E. & L.S. dated November 21, 2019 and as further described by metes and bounds dated November 7, 2019 prepared by Harold E. Pellow & Associates, Inc. which are annexed hereto and incorporated herein.

Section 2. Authority of Agent. The Mayor, Municipal Attorney, Municipal Engineer and such other officials, employees and agents of the Township, are hereby authorized and directed to perform all acts necessary to acquire the aforementioned roadway dedication and any other dedication, if any, set forth herein on behalf of the Township and the Mayor and Municipal Clerk are hereby authorized and directed to execute any and all documents necessary for the acquisition of the roadway dedication and any other dedication, if any, as set forth herein.

Section 3. All costs, if any, connected with title reports, appraisal reports, attorney fees, professional consulting fees and other costs necessary for the acquisition of said dedications shall be paid by the Grantor.

Section 4. Copies of this Ordinance shall be on file in the Office of the Township Clerk and are available for inspection. The Township Clerk shall, within sixty (60) days of the effective date of this Ordinance, file a copy of this Ordinance certified by her under seal of the Township to be a true copy thereof, together with a copy of the proof of publication thereof, with the Clerk of Sussex County.

Section 5. It is the interest of the Township Committee to vacate the aforementioned interests the public may have in the right of way, and to provide that all interest in the right of way, in its "as is" condition, be conveyed to the adjoining property owners.

Section 6. The Mayor and Township Clerk are authorized and directed to execute any documents as may be required to complete the transfer of whatever interest the public may have had, now vacated, in the property described above.

Section 7. If any part of this Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portion of the Ordinance. Any Ordinance or portion thereof that may be inconsistent with the Ordinance is hereby repealed to the extent of the inconsistency.

Section 8. Effective Date. This Ordinance shall take effect in the time and manner prescribed by law.
