

## **WANTAGE TOWNSHIP**

### **ORDINANCE #08 -2022**

#### **FULLY FUNDED ORDINANCE TO PROVIDE FUNDING FOR THE PURCHASE OF ONE DPW TRUCK AND APPROPRIATING THE SUM OF \$123,665.00 FOR PURCHASE OF DPW TRUCK**

BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Wantage, County of Sussex, State of New Jersey as follows:

SECTION 1: The sum of One Hundred Twenty Three Thousand, Six Hundred and Sixty-Five dollars (\$123,665.00) is hereby appropriated for Purchase of DPW Truck in Wantage Township funded in the amount of Forty Thousand Dollars (\$40,000.00) from the Capital Improvement Fund and Eighty-Three Thousand Six Hundred Sixty Five Dollars (\$83,665.00) from the American Rescue Plan Act of 2021.

SECTION 2: In connection with the amount authorized in Section 1 hereof, the Township makes the following determinations:

- 1) The purpose described in Section 1 hereof is not a Current Expense and is a purchase the Township of Wantage may lawfully make as a capital purchase.
- 2) The Township of Wantage hereby authorizes the purchase of a 2023 Ford F-550 Chassis 4x4 from Route 23 Automall, 1301 Route 23, Butler, NJ 07405 in an amount not to exceed \$123,665. Said purchase is authorized using NJ State Contract, Contract 17-FLEET-00241.
- 3) The period of usefulness of the purpose described in Section 1 hereof is not in the limitation of said Local Bond law and according to the aggregate reasonable life thereof is five (5) years or longer.

SECTION 3: The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of an inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services as on file with the Municipal Clerk of the Township of Wantage and is available for public inspection

SECTION 4: This ordinance becomes effective immediately upon publication after adoption.
