

**TOWNSHIP OF WANTAGE
ORDINANCE # 22-2026**

**An Ordinance Amending Chapter 21, Section 21-3: General Fees and
Section 21-11 Registrar Fees of the Revised General Ordinances
of the Township of Wantage, New Jersey
Authorizing Changes to Certain Fees**

WHEREAS, the Mayor and Township Committee of the Township of Wantage have determined that costs of certain services provided by the Township to its residents and others do not cover the costs of providing those services.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Wantage, County of Sussex, State of New Jersey as follows:

Section 1. Chapter 21 Fees

Section 21-3: General Fees shall be amended to change the fee for Bulky Waste Collection Sticker to not more than \$100.00, as determined by the Township Committee from time to time by Resolution.

Section 2. Chapter 21 Fees

Section 21-3: General Fees shall be amended to delete the fee for Radon Kits in its entirety.

Section 3. Chapter 21 Fees

Section 21-3: General Fees shall be amended to change “Certifying Copy of Document As True Copy” to \$15.00.

Section 4. Chapter 21 Fees

Section 21-3: General Fees shall be amended to delete “Typewritten Copy of Document” in its entirety.

Section 5. Chapter 21 Fees

Section 21-3: General Fees shall be amended to delete “Voter Registration Card/Certification Miscellaneous Fee” in its entirety.

Section 6. Chapter 21 Fees

Section 21-11: Registrar Fees shall be amended to change the Fee for certified copies of Birth Certificates, Death Certificates and Marriage Certificates to \$15.00.

Section 7. Chapter 21 Fees

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

Section 8. Effective Date.

This Ordinance shall take effect immediately upon final passage and publication according to law.
